- 1. That AAI members do not support athletic events without permits and that clubs actively ensure that athletic events in their area have permits. (*This motion is not referring to BHAA Events*) BOARD OFFICERS

- 3. That where postponed competitions have to be held in the following year, the age requirements of the competition be the same as the original date, i.e. if the 2010 competition is postponed to 2011, it be regarded as a 2010 competition. LISCARROLL
- 4. That all national results be submitted to Irish National Newspapers and National Athletics Magazines for publication National. BANDON
