Athletics Ireland

System Theory

- The system designed by Athletics Ireland & Eventmaster works as follows:
- 1. Clubs & Promoters can apply for a permit online via the Athletics Ireland website
- 2. After submission, the event is created automatically on the Athletics Ireland Events system
- 3. After permit approval by the County Board the event can be published for sale. AAI Members will benefit from a reduced entry fee into Athletics Ireland accredited events, non-members will pay a one-time levy or annual subscription
- 4. Upon completion of the event Athletics Ireland Members and annual subscription holders will have access to a results portal as part of 'Manage My Account' where they can access all their results and AAI member benefits



Step 1: Permit Application Process

- Permit Applicants go to the Athletics Ireland homepage to action a new event permit application.
- Applicants are directed to the permit application page to initiate the type of permit they wish. School, Club, Charity or Commercial/International Permit.
- Applicant fills the permit required data followed by the event registration core information.
- Processes a payment for the permit.
- Permit is submitted for approval of the County Board.






Step 2: Event Setup Process

- After the permit has been submitted the event page for the corresponding event will be **auto created by the system**
- The event will be created in the Athletics Ireland Events Admin account on the registration system.
- A user account will also be created for the event promoter if they are a new user. If they are an existing user, it will be added to their account.
- The AAI admin user will liaise with the promoter to complete the event setup and connect a Stripe account so they can receive live payments
- Once the permit is approved the event can be published for sale



Benefits to Members

- AAI members will have access to their results via a member's portal. This portal will collect all results from AAI events. The user can then view these completed events and their times within their user profile.
- AAI members will **not** have to pay the event levy that will be added to non-members entry for access to AAI permitted road races.
- Members will be able to access the AAI members benefits area giving them a variety of benefits including agreed discounts for products etc.
- The additional profit generated from non-AAI members will be ring fenced to jointly support members in HP and Coaching & Development.

Benefits to Clubs & County Board

- Clubs will benefit from their members receiving further benefits as part of their membership.
- Clubs will be able to access results easier through the portal system.
- We expect overtime that clubs will see an increase in membership as the perceived value of their membership increases.
- As AAI are collecting and subsequently able to reach out to a wider audience the potential to further grow club membership will increase.
- The AAI website will direct people to clubs in each geographical area.
- Clubs will benefit from the additional profit generated through further support from AAI at both HP & Development levels.
- Signoff of event permit will be streamlined.

 County Board will retain the full permit application fee associated with each application within their county once the permit is processed.

Benefits to Event Promoters / Race Organisers

• Promoters will benefit from the new website to market their event.

- Promoters will have a significant AAI marketing package at their disposal by having their event identified as an AAI permitted event.
- All participants will have a personal accident insurance provided through the levy.
- Their event will be listed on the list of upcoming events on the new website.
- Promoters can benefit from the AAI social channels to further promote their event.
- Promoters can benefit by allowing people to register their interest before the event goes on sale.
- Promoters will benefit from the streamlined Permit application process.
- Ease of setting up events online with the permit application process all in one go.
- Promoters will benefit from the extensive database that AAI has and will be issued through weekly and monthly newsletters.



Summary

- AAI want to own this space.
- We currently permit 650 events average size approximately 400 people participating but only 20% are AAI members.
- All profits will be ringfenced and go directly back to members through HP & Coaching & Dev.
- Technology is now driving all event entries and sales.
- Demand for a one stop solution and athlete database.
- All non-AAI members will be covered with a personal accident insurance.
- Small cash events can be facilitated off system if required.
- School events could be facilitated off system if required.
